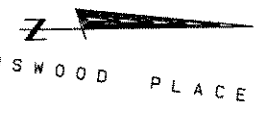


**PLAN OF SUBDIVISION OF LOT 3, D.L. 7765,
PLAN LMP 44369, GP. 1, N.W.D.**

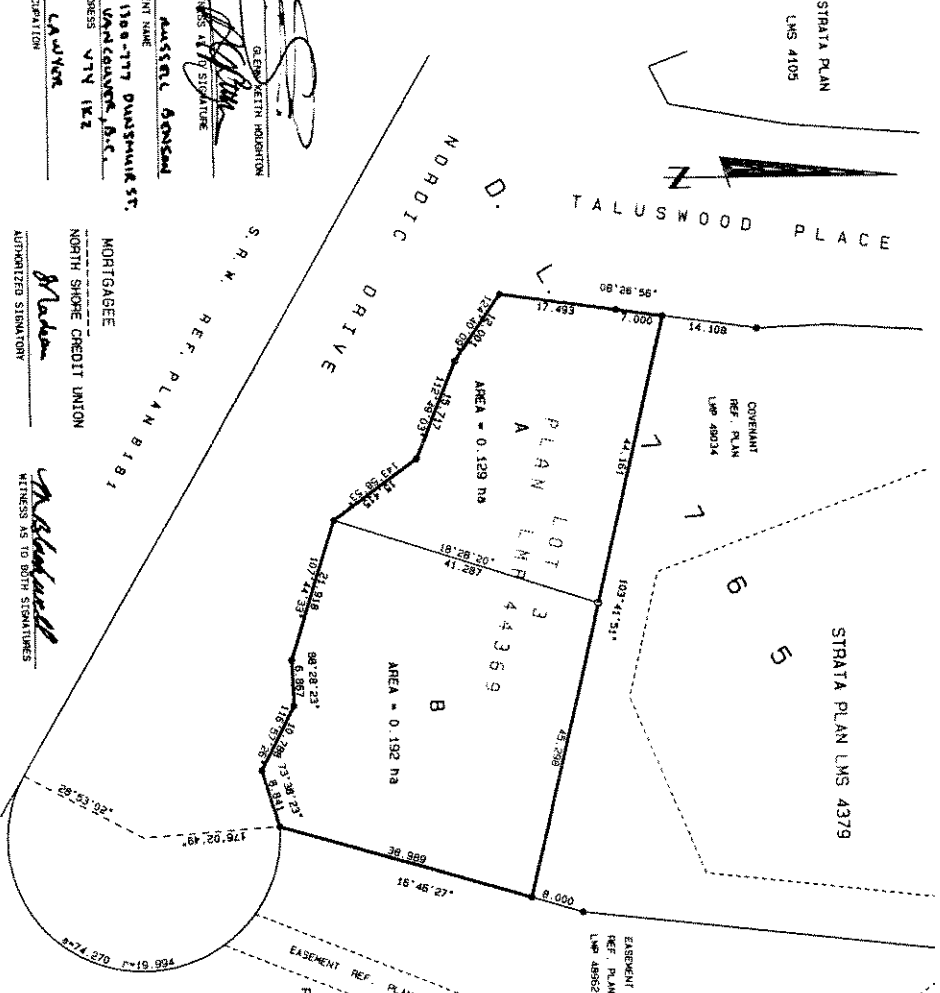
